

ORDINANCE NO. G-1154

AN ORDINANCE AMENDING CHAPTER 105 ENTITLED "ADMINISTRATION" OF TITLE I ENTITLED "COMMISSION MEETINGS" OF THE CODE OF THE CITY OF JUNCTION CITY, KANSAS BY AMENDING SECTION 105.200 ENTITLED "ROBERT'S RULES OF ORDER"

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF JUNCTION CITY, KANSAS:

SECTION 1. Section 105.200 of Chapter 105 of Title I of the code of the City of Junction City, Kansas is hereby amended by repealing said section and enacting in lieu thereof the following:

Section 105.200 **CODE OF PROCEDURE FOR KANSAS CITIES**

- A. There is hereby incorporated by reference for the purposes of operating Commission Meetings of the City of Junction City, Kansas that certain Code of Procedure known as the "Code of Procedure for Kansas Cities, Second Edition", prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas save and except such Articles, Sections, parts or portions as are hereinafter emitted, deleted, modified or changed or have been previously modified, changed or added.
- B. Section 12. Order of Business, shall be amended as follows:
At the hour appointed for the meeting, the mayor shall call the meeting to order. The vice mayor of the commission shall chair the meeting in the absence of the mayor. Upon having a quorum present, the governing body shall proceed to business, which shall be conducted in the order set by the governing body.
- C. Section 36. Same; Ordinary Ordinance; Commission City, shall be amended as follows:
The adoption of any ordinary ordinance requires three (3) affirmative votes of the commission.
- D. Section 38. Same; Charter Ordinance; Commission City, shall be amended as follows:
The adoption of a charter ordinance requires four (4) affirmative votes of the commission. The mayor is considered a member of the governing body.
- E. The following sections shall be deleted: Section 32. Votes; Mayor in Council City; Non-Ordinance, Section 33. Same; Ordinary Ordinance; Council City, Section 34. Same; Ordinary Ordinance; Council City; Mayor's Vote, Section 35. Same; Ordinary Ordinance; Council City; Mayor's Veto, Section 37. Same; Charter Ordinance; Council City, Section 39. Same; Council City; Confirmation of Mayoral Appointment to Non-Elected Position, and Section 40. Same; Council Cities; Confirmation of Mayoral Appointment to Elected Position.

SECTION 2. This ordinance shall become effective upon publication in the Junction City Daily Union as required by law.
