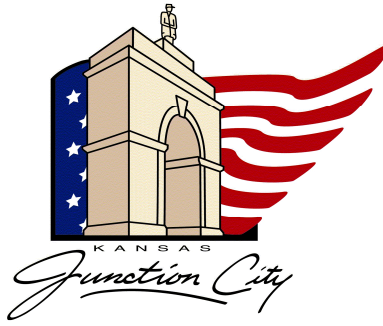

- * Map of the route described above.
- * Surety Bond in the amount of \$1,000.00.
- * Mover's Bond in the amount of \$5,000.00.
- * Sufficient drawings, prepared and signed by a registered Kansas design professional, including a site survey and site plan, drawn to scale.

1. Permits are not approved until you have them in your possession.
2. A Storm Water Prevention Plan shall be on site until the entire site has 70% vegetation and a notice of termination has been sent to KDHE.
3. Zoning Requirements:
 - * Setback in accordance with City Ordinance Section 405
 - * Storm Water runoff in accordance with City Sub Division Regulations
 - * Site Plan, prepared and signed by a registered Kansas design professional, drawn to scale
 - * No obstruction in easement i.e. fences, trees, shrubs, detached buildings
4. Required Inspections:
 - * Inspection of structure to be moved, prior to move
 - * Inspection of lot where structure is to be moved, prior to move
 - * Footing
 - * Foundation
 - * Sewer Tap, Trench & Compaction
 - * Water Line, Trench & Compaction
 - * Framing
 - * Mid Roof
 - * Final Roof
 - * Rough Electrical, Rough Plumbing, Rough Mechanical, Rough Gas
 - * Final Electrical, Final Plumbing, Final Mechanical, Final Gas, Wall Finishings, Grading, Sidewalks, Driveways and Erosion Control

Fees:

There will be a \$30 inspection fee to inspect the structure prior to moving.

Mileage outside of City limits is charged per the current IRS fee.

The permit fee is \$.20 per square foot, per story, excluding open porches.

This permit application must be completed in its entirety with all required attachments and must be signed by the applicant or it is considered null and void.

This form is made in accordance with the provision of the code requiring such permit and the proposed construction or work will be done in accordance with the terms of said code.

I, as applicant, agree to conform to all applicable codes and ordinances of the City of Junction City and/or Geary County, Kansas. I certify that the facts and information in this application, including any attachments, are true, complete and accurate to the best of my knowledge.
