

ORDINANCE G-1229

AN ORDINANCE AMENDING SECTIONS 595.130, ENTITLED "PERMIT TO BE SECURED", ADDING 595.135, ENTITLED "WORK COMMENCING BEFORE PERMIT ISSUANCE", AND AMENDING 595.340, ENTITLED "PENALTY" OF CHAPTER 500, ENTITLED "GENERAL PROVISIONS," OF TITLE V, ENTITLED "BUILDING AND CONSTRUCTION" OF THE CODE OF ORDINANCES OF THE CITY OF JUNCTION CITY, KANSAS, TO AMEND THE WORK PERMITS CONCERNING EXCAVATIONS AND SIDEWALKS

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF JUNCTION CITY, KANSAS:

SECTION 1: Section 595.130 – "Permit to Be Secured" of the Code of Ordinances of the City of Junction City, Kansas is hereby amended to read as follows:

Section 595.130 PERMIT TO BE SECURED

It shall be unlawful for any person or persons, company or corporation to cut pavements or make excavations in the streets, alleys, or other public grounds in this City for any purpose, unless such person, persons, company or corporation first obtain a permit authorizing such excavation, which shall be issued by the City Engineer or his authorized agent and the payment of a permit fee of one hundred dollars (\$100.00). The person, persons, company or corporation asking for the permit shall be required to pay the full amount to replace the curb, gutter and/or street according to City specifications, or shall pay a sum equal to the City Engineer's estimate for replacement of said pavement by the City based on the current costs for such work. Any cut, excavation, or other work regarding sidewalks, and solely sidewalks, shall conform to the Building and Engineering Standards of the City while not requiring a permit fee.

SECTION 2: Section 595.135 – "Work Commencing Before Permit Issuance" of the Code of Ordinances of the City of Junction City, Kansas is hereby written to read as follows:

Section 595.135 WORK COMMENCING BEFORE PERMIT ISSUANCE

Any person who commences any work on a cut pavement, excavation as listed in 595.130, and/or sidewalk before obtaining the necessary permits shall be subject to a fee established by the Code Administrator that shall be in addition to the required permit fees. This additional fee shall be \$100.

SECTION 3: Section 595.340 – "Penalty" of the Code of Ordinances of the City of Junction City, Kansas is hereby amended to read as follows:

Section 595.340 PENALTY

Any person, firm or corporation violating any of the provisions of this Chapter shall be deemed guilty of a misdemeanor and upon conviction thereof shall be fined in a sum no more than five hundred dollars (\$500.00) or imprisonment for a period not


exceeding thirty (30) days or sentenced to both such fine and imprisonment in the discretion of the Municipal Judge.

SECTION 4. All ordinances and parts thereof that are inconsistent with any provision of this Ordinance are hereby repealed.

SECTION 5. This Ordinance shall be effective upon publication as required by law. Passed and adopted by the Governing Body of the City of Junction City, Kansas this 2nd day of October, 2018.
