

Commissioner McCallister moved, seconded by Commissioner Sands to appoint Pat Landes as chair, Richard Rothfus, Randy Heldstab, Leon Osborn, Lance Custer, Robert Munson, Garry Junghans, Laurie Crites, and Randall Zimmerman to the Ad Hoc Committee. 
